

2010 PESTICIDE APPLICATOR CERTIFICATION WINTER TEST SCHEDULE - **REVISED 02/10/10**

It is **STRONGLY RECOMMENDED** testers use the field test sites. Tests are given in Des Moines on the first floor of the Wallace Building at the pesticide bureau any day state offices are open. No test is handed out before 9 a.m. or after 3 p.m. Tests are given on a first-come, first-serve basis. TEST SPACE AT THE OFFICE IN DES MOINES IS LIMITED TO LESS THAN 10.

1. Photo ID required. All tests are available at all sites.
2. No test will be handed out **BEFORE** the scheduled starting time or **AFTER** the scheduled closing time.
3. Cancellations. Weather is the most likely reason for change in the schedule. If winter driving is hazardous in your area, please call the PESTICIDE BUREAU at 515-281-5601 or 515-281-8591 to check on any possible change in time or cancellation.

(The testing location will be notified of any change in the schedule as soon as possible. Call the phone number for the testing location shown on this schedule ONLY to confirm testing or to ask directions to the testing site.)
